MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (here in after called as 'MoU') is entered into on this the 18.02.2022 by and between

Sree Abiraami Arts and Science College for Women, Keelalathur, Gudiyatham, The First Party represented herein by its Name of Competent Authority / Representative (herein referred as 'first Party', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in – office, administrators and assigns).

AND

Arivu Thirukovil , Manavalakkalai Mandram Trust, Gudiyatham, The Second Party, and represented herein by its Zonal / Divisional Head, Name of Competent Authority/ Representative, (herein after referred to as 'Second Party', Institution which express unless excluded by or repugnant to the subject of context shall include its successors – in – office, administrators and assigns).

(First Party and Second Party are herein after jointly referred to as 'Parties' and individually as 'Party') as

WHEREAS:

- A) First Party is a Higher Educational Institution named:
Sree Abiraami Arts and Science College For Women, Keelalalthur, Gudiyatham
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Yoga Based Training and Education.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.
- E) **Arivu Thirukovil , Gudiyatham Manavalakkalai Mandram Trust – The**

Second Party is engaged in provide new and good quality courses through good quality training, implementing it through the best instructors in a systematic manner.

- F) **Arivu Thirukovil , Gudiyatham Manavalakkalai Mandram Trust** – the Second Party is promoted by promoter name Group; Address and background of the Institution.
- G) Give related information, its branches, and dimensional information about the course concerned with whom the MoU is sworn.

NOW THEREFORE, the aforementioned parties have agreed to the terms and conditions as mentioned herein after in order to opening and provide for functioning of a centre for Yoga on the campus of SAWC, Gudiyatham.

1. That the Centre for Yoga (herein after referred to as Centre) shall work initially for a period of three years which can be renewed further from time to time as per the mutually agreed terms and conditions.
2. That during the first six months the Centre shall function purely on probationary period, during which period, the activities of the Centre shall be closely monitored by a Coordinating Committee. The Parties agree that, during the probationary period, the Principal of the Institute shall, upon the recommendations of the Coordinating Committee, have full authority and power to terminate the present MOU without assigning any reason in this regards. Conversely, the Second Party shall have full freedom to close the Centre, if it so wishes, after giving fifteen days notice to the principal, SAWC Gudiyatham.
3. That after successful functioning for six months, it will be deemed by Parties that the probationary period has been completed successfully and there after the Parties shall be liable to serve at least one month's notice on the other Party before terminating the present MOU
4. That the Centre will be fully dedicated for training by means of Yoga. It shall be entitled to demonstrate such experiments and exercises as may be permissible for the Party on the First Part. Second Party can start various schemes for the benefit and welfare of human being for example Training, Courses, Seminars, Conferences.
5. That the First Party shall provide necessary infrastructure without any charges with regard to premises and provide for its cleaning, gardening, furniture and equipments including civil maintenance, repairing, water and electricity supply, internal telephone which are deemed essential

and necessary to run the centre on the campus. All equipments and infrastructure provided to the Centre shall continue to be property of the Institute.

6. That the Second Party will provide technical staff to run the centre. All of them will be governed by the first party i.e., Gudiyatham Manavalakkalai Mandram Trust and would not demand any right or entitlement to be treated as or at par with the Institute employees.
7. That the staff of the Centre shall be placed under the command and control of the Administrator of the centre and would be expected to follow the code of conduct applicable to the Institute Employees. However, the Coordinating Committee shall be entitled to issue, from time to time, such oral or written instructions to the Centre for compliance, as it may, in its considered wisdom, deem appropriate.
8. The centre may run special courses from time to time, for which announcements shall be made by e-mail/posting on the Notice Boards/news paper advertisement. The cost of giving an advertisement in the news paper shall be borne completely by the Second party. For any such course a maximum of 50 % of the seats will be reserved for entitled persons. Also there shall be a 50 % subsidy on the fee charged. The course shall not run in case the participation from the entitled persons is less than 25 %.
9. That the first party shall maintain a visitors' complaint and suggestion register, which shall be monitored by the coordinating committee.
10. That in case of any dispute or differences between the Parties, the decision of the Principal of the Institute shall be final and binding on the both parties.
11. That no new activity shall be under taken by the Centre without the prior approval of the Director of the Institute.
12. That the Institute shall not be responsible directly, indirectly or vicariously in respect of any act, commission or omission committed by the Centre whether on the campus or the repercussion there of may take elsewhere. It shall be the sole responsibility of the administrator of the Centre to deal with the unforeseen or untoward circumstances arising within the premises of the Centre.
13. That under no circumstances, the Second Pary shall be responsible or answerable for any injury claim, compensation or award of the Court or Statutory Authorities.
14. That the Institute, in its own discretion, may order shifting of the Centre from one location to another location in the interest of the Institute.

15. This Agreement will be valid for 3 years or until it is expressly terminated by either party on mutually agreed terms, during which period Arivu Thirukovil - Gudiyatham Manavalakkalai Mandram Trust, the second party as the case may be, will take effective steps for implementation of this MOU. Any act on the part of Arivu Thirukovil - Gudiyatham Manavalakkalai Mandram Trust, the second party after termination of this Agreement by way of Communication, Correspondence etc., shall not be constructed as an extensions of this MOU.

16. The Fees Structure of the Course is as follows

- The Foundation Course – 30 hours duration – Rs. 150
- The Certificate Course – 50 hours duration – Rs. 500
- Diploma Course – 1 Year duration – Rs. 800
